Cookie Name	Type of Cookie	Purpose	Duration*
ARRAffinitySameSite	Standard Azure cookie that is part of the infrastructure of the website	Used for load balancing to make sure visitor page requests are routed to the same server in any browsing session	End of browsing session

*Duration means the period that our cookies are installed on your device. At the expiry of this period you will be asked to agree to the cookies again on our Website (except where the relevant cookie is a "Necessary Cookie").
